# **Teacher Requests - 6:48pm**

VERONICA MEOLA, President

- V. Review of spreadsheet for teacher requests
  - A. \$667 per classroom \$1,550
  - B. TOTAL FUNDING REQUEST: \$15,566
- VI. Part of reason for conservative proposed budget, to have consistency year-overyear, and to evaluate value for each student
- VII. Spoken with each teacher regarding priorities, specifics
- VIII. Yellow squares on spreadsheet 1 indicate optional/flexible requests
- IX. Amended spreadsheet \$10,623, 276 students
  - A. JASMEET VIRK: Provocation bins are not needs but are a priority as, primary education goals are to support curiosity and literacy, and provocation bins support curiosity
  - B. MADISYN PEARLE: Can teachers share bins?
  - C. JASMEET VIRK: Yes, each teacher will choose one bin to build this year.
- X. JENN DICKIE proposes that BIG WHITE Field Trip which is for all intermediate classes, should be a PAC Sponsored field trip, cost is approximately \$2,000. JASMEET VIRK brought up the YEAR END FIELD TRIP grade 5 to Garden Lake
- XI. TEACHER REQUESTS:
  - A. Motion to approve all teacher requests excluding the following items (reasons provided):
    - a) Provocation Bin, being funded by administration
    - b) OZOBOTS, existing technology just received
    - c) INDIGENOUS KNOWLEDGE SEEKERS, deferred as grant funding may be forthcoming
    - Motion to approve by GINA-LILY COOPER, seconded by VERONICA MEOLA. *Motion passed by majority*.
    - 3. JORDIN KUTT important to fund teacher requests, this is why we fundraise, mentioned that she would want to oppose based on not covering all teacher expenses but then changed her mind and withdrew opposition
- XII. JENN DICKIE: Motion brought to approve additional \$15/grade 5 student and \$5/grade k-4 student to cover year end celebration at teacher discretion.
  - A. Motion to approve by JENN DICKIE, seconded by GINA-LILY COOPER. *Motion* passed by majority.
- XIII. VERONICA MEOLA to write letter detailing what funding has been approved and outlining new procedures for reimbursement

XIV. JASMEET VIRK: will follow up on exclusions, also so excited to hear we are funding all the teacher requests, and to see such a stand for teachers and the love and care for the students at Pearson. It is special and unique to Pearson.
